**PROPOSITIONS**

**COALER SPRINGS PARK DISTRICT**

**SHALL THE PROPOSED COALER SPRINGS PARK DISTRICT BE ORGANIZED AND ESTABLISHED AS A GENERAL PARK DISTRICT UNDER THE PROVISIONS OF THE PARK DISTRICT CODE IN THE TERRITORY DESCRIBED AS FOLLOWS:**

Sections one (1), two (2), three (3), four (4), five (5), six (6), seven (7), eight (8), nine (9), ten (10), eleven (11), twelve (12), thirteen (13), fourteen (14), fifteen (15) sixteen (16), seventeen (17) and eighteen (18) in Township Thirty-Two (32) North, Range Eight (8) East of the Third Principal Meridian, all situated in the County of Grundy, State of Illinois. Sections one (1), two (2), three (3), and the North one-half (N ½) and the Southeast Quarter (SE ¼) of Section four (4); sections nine (9), ten (10), eleven (11), twelve (12), thirteen (13), fourteen (14), fifteen (15), sixteen (16); the South one-half (S ½) of Section seventeen (17); that part of Section twenty (20) situated North of and East of the Mazon River; sections twenty-one (21), twenty-two (22), twenty-three (23), twenty-four (24), twenty-five (25), twenty-six (26), twenty-seven (27), twenty-eight (28) and that part of section twenty-nine (29) situated East and South of the Mazon River; and that part of Section thirty (30) situated South of the Mazon River; Sections thirty-one (31), thirty-two (32), thirty-three (33), thirty-four (34), thirty-five (35) and thirty-six (36) in Township thirty-three (33) North, Range Eight (8) East of the Third Principal Meridian, all situated in the County of Grundy and State of Illinois. Those parts of sections twenty-five (25), twenty-six (26), twenty-seven (27), twenty-eight (28) and thirty-three (33) situated South of the Illinois River and that part of section twenty-five (25) situated East of the Kankakee River and South of the Des Plaines River and all of sections thirty-four (34), thirty-five (35) and thirty-six (36) in Township thirty-four (34) North, Range Eight (8) East of the Third Principal Meridian, all situated in the County of Grundy and State of Illinois. The South one-half (S ½) of Section twenty-five (25) and all of section thirty-six (36) in Township thirty-three (33) North, Range Seven (7) East of the Third Principal Meridian, all situated in the County of Grundy and State of Illinois.
