NOTICE

Grundy County Sheriff's Department is requesting a quotation for the purchase and delivery of Unleaded Gasoline. This quotation is for an annual contract that anticipates the purchase of approximately 60,000 gallons of unleaded fuel.

Quotations will be accepted at the Grundy County Sheriff's Department, 111 East Illinois Avenue, Morris, IL until 10 a.m. on January 5, 2017.

Tax Exemption:

Grundy County may be exempt from certain State, Municipal or Federal Excise Taxes. Each bidder must be prepared to file for any refund relating to said taxes. Grundy County is not to be billed for any exempted Federal and/or Sales Taxes.

Quantity Requirements:

It is estimated that the Grundy County Sheriff's Department will require approximately 60,000 gallons of 87 octane gasoline delivered to the Sheriff's Department during the term of the contract. This contract will be for a twelve month period, commencing January 11, 2017 and ending January 9, 2018.

Decreases to Estimated Quantities: The quantities heretofore identified are estimated only. Grundy County reserves the right to decrease the amount of fuels purchased under this contract with no penalties, fees, or additional charges.

Increases to Estimated Quantities: In the event Grundy County purchases more than 60,000 gallons of unleaded gasoline, the Vendor may increase the per-gallon price charged for said fuels; however, the price per gallon shall not exceed the Vendor's rack price on the date of delivery plus 10¢ per gallon.

Prices:

Prices shall remain in effect throughout the length of the contract, and shall be a FIXED RATE PER GALLON.

If the Federal Government, through any of its agencies, imposes price controls or pricing rules during the term of the contract, the supplier shall comply with such rules and regulations. Grundy County will **not** be responsible for any such increase in cost during the length of the contract.

SPECIFICATIONS

87 Octane Unleaded Gas

Unleaded gasoline shall have a minimum octane rating of 87 (R+M)/2 and shall not contain more than 10% alcohol-based fuel. It shall also comply with all of the latest federal and state requirements for unleaded fuels.

DELIVERY

Fuel shall be delivered to and placed in the 1000-gallon tank provided by the City of Morris located at 289 N. River Road, Morris, IL 60450.

All deliveries to the City of Morris shall be as directed by the Grundy County Sheriff. Any additional deliveries shall be made within twenty-four hours of notification of the need for gasoline. The successful bidder shall be directly responsible for any and all delivery charges. Do not include any delivery charges on your quotation. Grundy County will pay no delivery charges.
